#### **ORDINANCE NUMBER 23-2987**

# AN ORDINANCE TO REZONE CERTAIN REAL ESTATE IN THE CITY OF SHELBYVILLE, INDIANA, AND TO REPEAL ALL ORDINANCES IN CONFLICT THEREWITH TO THE EXTENT OF SUCH CONFLICT ONLY

**BE IT ORDAINED** by the Common Council of the City of Shelbyville, Indiana, as follows, to-wit:

- **Section 1.** That the following tracts of real estate in the County of Shelby, State of Indiana, listed in Exhibit B, and generally depicted in Exhibit A, attached hereto and incorporated herein be, are hereby designated the zoning classification of *R1 Single Family Residential*, and;
- **Section 2.** That the following tracts of real estate in the County of Shelby, State of Indiana, listed in Exhibit C, and generally depicted in Exhibit A, attached hereto and incorporated herein be, are hereby designated the zoning classification of *RM Multiple-family Residential*, and;
- **Section 3.** That the following tracts of real estate in the County of Shelby, State of Indiana, listed in Exhibit D, and generally depicted in Exhibit A, attached hereto and incorporated herein be, are hereby designated the zoning classification of <u>PK Parks and Open Space</u>, and;
- **Section 4.** That the following tracts of real estate in the County of Shelby, State of Indiana, listed in Exhibit E, and generally depicted in Exhibit A, attached hereto and incorporated herein be, are hereby designated the zoning classification of *IL Light Industrial*, and;
- **Section 5.** That the following tracts of real estate in the County of Shelby, State of Indiana, listed in Exhibit F, and generally depicted in Exhibit A, attached hereto and incorporated herein be, are hereby designated the zoning classification of *IS Institutional*, and;
- **Section 6.** That the following tracts of real estate in the County of Shelby, State of Indiana, listed in Exhibit G, and generally depicted in Exhibit A, attached hereto and incorporated herein be, are hereby designated the zoning classification of <u>BG Business General</u>, and;
- **Section 7.** That the following tracts of real estate in the County of Shelby, State of Indiana, listed in Exhibit H, and generally depicted in Exhibit A, attached hereto and incorporated herein be, are hereby designated the zoning classification of <u>AR Agriculture/Rural Residential</u>, and;
- **Section 8.** Any ordinance of the City of Shelbyville, Indiana, which is in conflict with the terms and provisions of this ordinance is hereby repealed, to the extent of such conflict only, as to the above-described real estate only.


